INFORMATION ON THE PROCESSING OF PERSONAL DATA

The maintenance of the site is carried out by: SVN ROMANIA REAL ESTATE ADVISORS SRL .

2. Types of personal data of people visiting our website that may be processed by the operator : name, surname, telephone number, address, email address, online identifiers such as: IP, location, video data at the headquarters.

Also, SVN Grup, together with its collaborators in the real estate field, may process your personal data, including upon conclusion or prior to the conclusion of a contract: name, surname, date of birth, username, telephone number, address, email address, CNP, series and number. CI, signature.

3. Why we need your data - to carry out the operator's specific activities and services.

4. Purpose of collecting personal data – **carrying out management, advertising, marketing, real estate sales or rental brokerage activities.**

5. The legal basis for processing your data, according to GDPR, art. 6, letters a, b, c, f, may be, as the case may be:

- consent (for cookies when accessing the site or newsletter - consent can be withdrawn using the attached form);
- the contract or steps regarding the conclusion of a contract with you (customer messages requesting details of property purchase or rental contracts or candidate messages for employment or collaboration contract);
- legal obligation in areas such as financial and fiscal
- legitimate interest – pursued by a third party (for example through Google Analytics cookies , or court actions).

6. What we do with your data - the employees of the operator - SVN Romania and the processor - the website maintenance company or our collaborators may process your personal data to perform their duties in the field of marketing, sales, management or advertising. Your data may also be legally requested and obtained by competent authorities, courts, the Police, other authorities. We do not use automated decision-making processes and we do not create profiles regarding your personal data.

7. How long do we keep your data - personal data is kept according to legal terms. On the site, some data such as digital markers can be kept for a maximum of 30 days - according to the cookie policy.

8. What are your rights?

The right to be informed about your personal data, the right to access personal data, the right to rectify data, the right to restrict processing, the right to erasure, the right to object to processing, the right to data portability, the right to object to automated decision-making or profiling.
